This agreement is entered into on this date, _____ by and between the Second Chance League (SCL) of Fairbanks, Alaska, and _____, hereafter referred to as the foster trainer.

1. I hereby acknowledge receiving the above-described dog(s).
2. I understand that the dog(s) shall remain the sole property of SCL. SCL reserves the right to reclaim the dog(s) at any time.
3. I agree to return said dog(s) if I am no longer able to care adequately for them.
4. I agree to return any foster dog that dies.
5. I agree to provide the dog(s) with good and loving care, including but not limited to food, water, shelter & medication when required. I agree not to breed the dog(s) or allow them to breed. I will provide or arrange for all emergency medical care and will notify SCL immediately if the dog(s) become ill or injured, requiring veterinary care. I also agree not to allow the dog(s) to be euthanized, unless it is clearly critically injured, without notifying SCL and obtaining permission in advance.
6. I understand & acknowledge that I do not have any right or authority to keep or place foster dogs in other homes or with other individuals.
7. I understand that said dog(s) will be available for adoption during the time in my foster care, unless otherwise stated above. I agree to allow the dog(s) to be viewed by potential adopters with 24 hours notice.
8. I understand that as the foster trainer, I have the first right of adoption of any dog(s) in my care when adoptive homes are available.
9. I understand & acknowledge that I am responsible for all general expenses incurred as a result of fostering a dog.
10. I understand & acknowledge the SCL cannot guarantee or be held responsible for the health, behavior or temperament of dog(s) that I may foster. I understand that neither SCL nor the Fairbanks North Star Borough Animal Shelter make any warranty or guaranty as to the demeanor, health, temperament, or pedigree of any animal. I expressly release and hold harmless both SCL and the Fairbanks North Star Borough from any and all liability for loss, injury, or damage caused by any animal to any person or property, and that I will assume any such risk of loss by fostering any animal.
11. I understand that my foster volunteer position can be terminated at any time at the sole discretion of SCL.
12. I agree to provide monthly reports for said dog(s).
13. I agree that SCL has the right to visitation with 24 hours notice or immediate inspection in case of emergency situations (i.e. earthquake, fire, flood, negligence, etc)
14. I agree to defend, indemnify, and hold harmless the SCL, its officers and assigns, any previous owner, foster home and the FNSB Animal Shelter from any and all liability associated with the dog(s) or damage or injury hereafter caused by the dog(s).

I attest that the terms and conditions of this foster contract have been read and understood, I agree to abide by them, and I am at least 18 years of age. I agree that any legal actions in connection with this agreement shall be brought solely in the 4th Judicial District of the State of Alaska and agrees to submit to said jurisdiction.
