## ADOPTION CONTRACT

### **I also agree to the following:**

I will provide the animal with adequate food, water and shelter at all times. I will provide a safe, fenced area for the animal (if a dog) to exercise in and will care for it in a humane manner, giving it time (at least two weeks) to adjust to its new surroundings. If a cat, I will provide a safe environment indoors or a safe barn, where the cat is supervised. I agree that no cat that is de-clawed will be allowed outside.

I will provide necessary veterinary treatment as needed, annual check-up and vaccines. For dogs I will provide heartworm prevention.

I will comply with all applicable local pet ordinances and include proper ID tags for the pet.

I will never allow this animal to ride in the open bed of any vehicle without a proper transportation restraint device, such as a pet carrier or approved harness.

I will make a donation of \$85 (for puppy/dog) or \$65 (for kitten/cat) payable to Save1Pet to help offset the costs of medical treatment, spaying/neutering, vaccinations and boarding fees. A more substantial donation may be required if pet has a large vet bill or greater medical expenses.

I will notify Save1Pet if I find, for any reason, that I am no longer able to provide this animal with a good home. You may email save1pet@yahoo.com to make arrangements.

If I cannot keep the animal, for any reason, I understand that a refund of fees will only be given within the first two weeks or replacement animal will be only be given within the first 30 days after the date of the adoption.

I understand that if the animal I am adopting is a longhaired pet, a poodle or terrier type, it will require special grooming, and I agree to see that its grooming needs are met.

**I hereby accept possession of this animal "as is" and at my own risk, hereby releasing and waiving any right against Save1Pet or its representative(s) which I may have now or may in the future incur for any damages to person or property caused by said animal or loss of said animal.**
